### Be Prepared for Severe Weather

Greetings to our Licensed Family Child Care Providers! I don't know about you, but it seems to us that this year is already flying by. We had a mild but also cool winter and now we are reminded that summer is right around the corner. We are including some information on severe weather. It is important that we make sure that we are all prepared to safely survive in our business that are our homes.

One of the most dangerous hazards is a tornado. Tornados are spawned by a thunderstorm or because of severe weather associated with hurricanes. Wind speeds in an intense tornado are likely to rise above 200 miles per hour. These violent winds are what make tornadoes so deadly. They can uproot and snap trees, down power lines, move or pick up cars and trucks, and destroy homes.

Tornadoes are not usually associated with the Sunshine State, but Florida ranks 5th nationally in the annual average number of tornadoes and ties for 6th in tornado fatalities with an annual average of 4 fatalities per year.

Please be sure you are practicing your emergency drills for tornados and lockdowns. Although regulations state that one of each is practiced in your licensing year, it is ok to practice more than once, especially when children in your care change. Remember that fire drills are practiced monthly at varying times of the day.

**Safety Tips:** How can you be prepared for Thunderstorms and Tornados?

•Learn your local severe weather/tornado warning system. Alert Pinellas is an emergency notification system that is used by Pinellas County public officials, municipalities, and the Sheriff's Office and to notify citizens within Pinellas County. You can sign up for free to receive emergency notifications via phone, text, or email. Sign up here: <u>Pinellas County, Florida -Alert Pinellas</u>

•Know the difference between a tornado watch and a tornado warning.

•Tornado Watch: Issued by the National Weather Service when tornadoes are <u>possible</u> in your area. You should remain alert for approaching storms.

•Tornado Warning: Indicates that a tornado has been <u>sighted in your area or is indicated on weather radar</u>. You should proceed to safe shelter immediately.

•Know the signs of a tornado

.•Discuss thunderstorm and tornado safety with all members of your household and create an emergency plan.

•Pick a safe place in your home for household members and or the children in care to gather during a thunderstorm/tornado warning. This should be away from windows, skylights and glass doors that could be broken by strong winds or hail

.•If you are under a thunderstorm warning, go inside when you

hear thunder and move from outdoors into a building or car with a roof.

•Create an emergency preparedness kit.

## **NEWS FROM EPIDEMIOLOGY** Increase in Chickenpox Cases—2023

Varicella (chickenpox) is a viral infection that causes an itchy blister-like rash. After initial infection, the virus can stay in the body and reappear later in life as Shingles. Chickenpox can cause serious infection and complications in babies and others with weakened immune systems including pregnant women.

Chickenpox spreads through the air but may also occur by direct contact with blister fluid. Chickenpox is highly contagious, infecting between 61-90% of those who are susceptible. Those with chickenpox are considered contagious until all lesions have crusted over, typically five days, and should be excluded from care during this time. The best way to prevent chickenpox infection is through vaccination. The vaccine is given in a two-dose series with the first dose given between age 12-15 months and the second at 4-6 years.<sup>1</sup> Vaccines are available through the Florida Department of Health in Pinellas County (DOH-Pinellas) on a walk-in basis.

Chickenpox typically follows a seasonal pattern with highest occurrence in winter and early spring.<sup>2</sup> In January 2023, DOH-Pinellas identified an increase in chickenpox cases compared to the same time last year (see graph below). Similarly, chickenpox cases increased statewide with 47 cases reported in January 2023, while 23 were reported in 2022.

Chickenpox cases are reportable in Florida and should be reported by the diagnosing provider.

# **UPCOMING TRAININGS**

## **RECORD KEEPING FOR CHILDREN'S CENTERS**

Is a four and a half (4 1/2) hour training comprised of an overview of regulations regarding record keeping including personnel, children, and facility records. Participants will receive a training packet that includes required and optional forms and learn practical ideas for setting up and maintaining files in order to be in compliance with regulations. This training is appropriate for

prospective or new owners/directors and as an update for current child care personnel with record keeping responsibilities. A certificate documenting four and a half (4.5) hours of annual in-service training will be issued.

## **PINELLAS DIRECTOR'S BASICS**

Is a three (3) hour training required for new directors who have not been directors previously in Pinellas County or have not been a director in Pinellas County in the last 12 months. This course is designed to foster success by covering regulations unique to Pinellas County, our website as a resource and best management practices. A certificate documenting three (3) hours of annual in-service training will be issued.

**Registration Fee: \$25 pre-paid** prior to training, non-refundable Time: 9:00am—12:00pm

## **DIRECTOR'S ORIENTATION FOR INFANT CARE**

Is a three (3) hour training comprised of regulations pertaining specifically to infant care and best practices in caring for children from birth to 2 years of age. Participants will receive a training packet that includes a copy of the Infant Standards, required and sample forms, and brochures. This training is required for directors who plan to start an infant program. A certificate documenting three (3) hours of annual in-service training will be issued.



**Registration Fee: \$25 pre-paid** prior to training, non-refundable Class time: 9:00am—1:00pm

## Q-Tip Painted Handprint Cherry Blossom Tree

#### Craft Supplies Needed:

- 1. Unused Q-Tips 2. White Craft Paint
- 3. Various Shades of Pink Craft Paint
- 4. Light-Blue and Brown Cardstock Paper
- 5. Small paper plate 6. Basic craft scissors
- 7. Pencil or Pen 8. Glue Stick

### **Directions:**

- Trace the child's handprint/arm onto the brown cardstock and cut it out. (this will be used for the trunk of the tree)
- Glue the hand/arm to the light-blue cardstock
- Put puddles of different color pinks and the white paint on the paper plate
- Have the child dip the Q-Tip into the paint and then dab onto the branches of their "handprint tree" until the tree is nice and full
