Employment History Checks

e'd like to share some reminders about the regulations on Employment History Checks with you as this year comes to a close.

- All 5-year employee history checks should be taken very seriously. It is a regulation that they be completed for all employees.
- 5-year employee history checks should be completed before hiring by calling the employers listed, verifying past employment, and comparing the information to what's listed on the bottom of a Background Screening. For example, if an

applicant says they were a stay-at-home mom or were selfemployed for two years and their background screening shows two different jobs listed during that time, the application is not filled out correctly.



We highly suggest you work to find the reason an applicant is not listing all past employment before thinking about hiring them to work with children and represent your center. You could do this by calling the employers listed on the background screening, or by doing a file review in our office.

It's that time of year when holiday decorations come out and excitement is in the air. It is also the time when questions about having poinsettias in licensed Children's Centers and Family Child Care Homes

arise. Poinsettias are not actually a poisonous plant, so they are allowed in Children's Centers and Family Child Care Homes. Because they may cause stomach irritation or pose a choking hazard, they should be kept out of reach of children in the licensed space, out of an abundance of caution. This refers to any space used by the children. Areas not used by the children, such as porches or public entrances could have poinsettias displayed at any height as the children would not be in group care in these spaces. NEWS FROM EPIDEMIOLOGY

Respiratory Syncytial Virus (RSV) Infection & Prevention

espiratory syncytial virus (RSV) is a common respiratory virus that usually causes mild, cold-like symptoms. Most people are able to manage the symptoms at home and recover within a week or two. Infants and older adults, especially those with underlying health conditions, are at a higher risk for severe illness and poor outcomes after infection.

RSV is spread when an infected person coughs or sneezes and the virus droplets make contact with your eyes, nose or mouth. An infected individual can be contagious from three to eight days or longer in some cases. RSV circulates throughout the United States annually and most RSV activity is observed during the Fall and Winter. Florida tends to experience an earlier season onset and longer duration than other areas of the coun-

RSV can be very dangerous for young children. Early symptoms in children may include runny nose, decrease in appetite

and cough and later infection presents as bronchiolitis and pneumonia. If infection leads to hospitalization, treatment includes oxygen, IV fluids and supportive care.

The Centers for Disease Control and Prevention (CDC) surveillance has identified an increase in RSV

At this time, there is no vaccine for RSV. If you have contact with infants or young children, you can take these steps to keep yourself and them healthy:

- Wash your hands. If soap and water are not available, use an alcohol-based hand sanitizer.
- 2. Avoid close contact with people who may be sick.
- 3. Clean and disinfect frequently touched surfaces.
- Stay home if you are sick and keep children home if they are experiencing symptoms.
- Cover your mouth and nose when sneezing. If you don't have a tissue, cough or sneeze into your upper sleeve or elbow, not your hands.

RSV in Infants and Young Children

Each year in the United States, an estimated 58,000-80,000 children younger than 5 years old are hospitalized due to RSV infection. Those at greatest risk for severe illness from RSV include:

- Premature infants
- Infants, especially those 6 months and younger
- Children younger than 2 years old with chronic lung disease or congenital (present from birth) heart diser
- Children with weakened immune systems
- Children who have neuromuscular disorders, inc those who have difficulty swallowing or clearing mucus secretions

Early Symptoms of RSV

RSV may not be severe when it first starts. However, can become more severe a few days into the illness. Early symptoms of RSV may include:

- Runny nose
- Decrease in appetite
- Cough, which may progress to wheezing or difficulty breathing

Severe RSV Infection

Virtually all children get an RSV infection by the time they are 2 years old. Most of the time RSV will cause a mild, cold-like illness, but it can also cause severe illness such as:

- Bronchiolitis (inflammation of the small airways in the lung)
 Pneumonia (infection of the lungs)
- Preturnona unrection of the lungs!

RSV in Very Young Infants

Infants who get an RSV infection almost always show symptoms. This is different from adults who can have few or no symptoms with RSV infection. In very young infants (less than 6 months old), the only symptoms of RSV infection mass have

- Irritability
- Decreased activity
- Decreased appetite
- Apnea (pauses in breathing more than 10 seconds)

What you should do if your child is at high risk for severe RSV infection

RSV season in most regions of the U.S. starts in the fall and
peaks in the winter. If you have contact with an infant or
young child, especially those who were born prematurely,
have chronic lung or heart disease or a weakened immune
system, you should take extra care to keep the infant health
by doing the following:

- Wash your hands often
- Keep your hands off your face
- Avoid close contact with sick people
- Cover your coughs and sneezer
- Clean and disinfect surfaces



emergency department visits and hospitalizations across the US. Currently in Florida, a higher number of reported cases and pediatric emergency department visits have been observed compared to previous years.

Parents should call their healthcare provider if their child is sick with RSV and having difficulty breathing or worsening symptoms. Childcare providers should monitor for illness in their facility and report any outbreaks to their local health department.
