#### **DOH-PINELLAS HIGHLIGHTS**

- In June 2022, the first monkeypox case was reported in Pinellas. DOH-Pinellas continued to work with partners to provide education and vaccines—while the agency was still dealing with the COVID-19 pandemic and a meningococcal disease outbreak in the state.
- DOH-Pinellas continued its health services at clinics funded by the Juvenile Welfare Board in five high schools. The clinics provide services to students in underserved areas and are used for Back to School events for the community during months when schools are not in session.
- With DOH funding, the Health Equity Team organized a community health event to increase minority health access. The focus was on bringing families to the Sanderlin Center for education, fun, food and screenings. Other community partners also took part.
- Breastfeeding peer counselors in the WIC division switched to online education sessions to reach more clients during COVID-19. Counselors presented sessions in English and Spanish at times convenient to families.
- Through its Mobile Medical Unit and Street Medicine Team, DOH-Pinellas provided care to persons experiencing homelessness. Both are part of the Pinellas County Healthcare for the Homeless initiative and are staffed by DOH-Pinellas professionals. These initiatives take quality care outside the physical clinics to provide more responsive care.
- As an integrated health system, DOH achieved a five-year certification from the Public Health Accreditation Board (PHAB), a national organization that advances performance improvement, quality services and innovation. DOH-Pinellas was one of only a few agencies among Florida's 67 county health departments that received virtual site visits by PHAB.

#### **COMMUNICABLE DISEASE**



**23,576** immunization services were provided to adults and children to protect them from disease.



10,200 sexually-transmitted disease (STDs) services were provided to diagnose and treat clients.



137,529 services were provided by Vital Statistics, where the public can request birth and death certificates.

### PRIMARY CARE (PERSONAL HEALTH)



7,375 adult health clients and 3,348 child health clients received primary care services.



**16,491** clients—mothers, babies and toddlers—were served by WIC, the supplemental nutrition program.



**37,551** services were provided by the Dental staff. The agency is the largest Medicaid dental provider in the county.



**805,131** services were provided by the School Health program to protect students.



41,693 services were provided by Healthy Start Prenatal; 34,864 families received Healthy Start services.

#### **ENVIRONMENTAL HEALTH**



10,168 inspections were completed at public pools and bathing places for your safety.



4,853 school cafeteria and other food service were inspected.


