This has certainly been a crazy last few months. We have all been through a lot as of late, and we have all learned things coming out the other side of these back to back hurricanes.

### Tammy's Tips

One of the biggest things that we struggled with here at Child Care licensing was knowing what was going on with you and your center. Yes, it is regulation that you check in with licensing after a disaster, but we also care and want to know how you are.

One thing we heard a lot post storm was that providers told us they had left a voicemail, but we did not have a message from you. As we also learned, you may not have the ability to contact licensing for a few days. All that being said, we ask that you do make every attempt to talk to someone at licensing and let them know your status. Your first step after the storm is to contact the State of Emergency Hotline at 727-369-3900 or the after hours emergency number (727-262-0247). Please do not reach out to your specialist as they may not be available to retrieve messages.



When there is an event such as a hurricane that cause shelters to be open, the Department of Health closes down as we staff the special needs shelters in Pinellas County. Therefore we ask that you do not leave a message on the office phone line because we do not know when we will be back in the office. We do have a few members of staff who's job it is, both during and post storm, to take your call on the after-hours line (727-262-0247), retrieve messages from the State of Emergency Hotline (727-369-3900), and/or have the ability to go out post storm for inspections if needed.

Not only do we need to know your status such opened or closed, we also need to know if you sustained any damage. Depending on the amount and type of damage, you may need an inspection prior to opening your center for children again. Our priority is the safety of children. We also had some centers that sustained so much damage they had to move to a different location. Prior to bringing children into a different location, licensing must inspect and measure the space to ensure it is a fit for child care.

If there is a delay in hearing back from someone at licensing, please do not hesitate to reach out to us again. We would prefer to have over communication instead of none at all.

The storms also caused DCF tests to be cancelled, and now there are a lot of providers and their staff trying to get rescheduled for tests. Please be patient as DCF attempts to catch up and get everyone in. We hope that you and yours are well, and that things are much calmer heading into this holiday season.

Adults aren't the only ones who feel stress. Children feel stress as well. With the recent hurricanes, a lot of children have had their lives upended, and they may have lost just about everything familiar to them. Having these children get back into a routine, including child care, is a great way for them begin to shed some of the stress they are holding.

In addition, doing some stress reducing activities may also help. The Mental Health Center has a great article titled ["101 Stress Relief Activities for Kids" by Michael Vallejo.](#) Most of the ideas are simple, and free. They include deep breathing exercises, exploring nature, and coloring.

If you notice a child who seems to carry a lot of stress for multiple days in a row, you should encourage the parents to ensure the child is getting enough sleep, eating healthy meals, and talking about why they feel stressed.

Sometimes changes in the child care environment may bring about stress for children. Some child care programs have had to move to alternate locations. It may take a little while for children to become comfortable in this new environment. If there is going to be a known change in regular routines for kids, in order to minimize stress, start talking about those changes prior to them occurring. Knowing what is coming will help children feel more in comfortable and they will in turn be able to better control their emotions due to stress.



Procare Solutions has an article about ["Stress Management in Child Care"](#). This article not only discusses stress in children attending child care, but also child care workers and the parents. They offer strategies such as self-care, support networks, and communication as ways to help reduce stress for all parties.



Finally, please remember to take care of yourself. You must be the best you can be to provide what the children in your care need. We have all been through a lot in the past few months, and stress levels may be higher than usual. We will persevere and get through this as a community. ## NEWS FROM EPIDEMIOLOGY Increase in Pertussis Cases—2024

PERTUSSIS

Pertussis (whooping cough) is a bacterial infection that causes spasms of severe coughing which may be followed by an inspiratory “whooping” sound, vomiting, or difficulty breathing. These coughing spasms often last one to six weeks but can continue for up to ten weeks after onset. Pertussis can cause severe infection in infants and people with weakened immune systems, including pregnant women.

Pertussis spreads in the air by respiratory droplets produced from coughing, sneezing, or talking, or through direct contact with these respiratory secretions. Pertussis is a highly contagious illness best prevented by vaccination. The DTaP (diphtheria-tetanus-acellular pertussis) vaccine is a five-dose series administered at ages 2 months, 4 months, 6 months, 15-18 months, and 4-6 years. The Tdap booster is recommended between ages 11-12 to extend protection. Adults should receive a Tdap booster every 10 years, and pregnant women should receive a booster during each pregnancy to pass along protection to their baby until they are old enough to receive their first dose<sup>1</sup>. Vaccines are available through the Florida Department of Health in Pinellas County (DOH-Pinellas) on a walk-in basis.

Prior to the COVID-19 pandemic, an average of 10,000 cases of pertussis were reported across the U.S. each year<sup>2</sup>. During the pandemic, cases of pertussis dropped below average levels, possibly due to cross-protective measures. In 2024, increases have been identified nationally<sup>3</sup>. Pinellas has reported 21 reported cases as of November 2024, compared to 1 reported case in 2023.

DOH-Pinellas advises parents to follow up with their pediatrician if their child is experiencing symptoms. Please contact DOH-Pinellas Epidemiology Program at 727-824-6932 with any questions or concerns.

## UPCOMING TRAININGS

### RECORD KEEPING FOR CHILDREN'S CENTERS

A four and a half (4 1/2) hour training comprised of an overview of regulations regarding record keeping including personnel, children, and facility records. Participants will receive a training packet that includes required and optional forms and learn practical ideas for setting up and maintaining files in order to be in compliance with regulations. This training is appropriate for prospective or new owners/directors and as an update for current child care personnel with record keeping responsibilities. A certificate documenting four and a half (4) hours of annual in-service training will be issued.

### PINELLAS DIRECTOR'S BASICS

A three (3) hour training required for new directors who have not been directors previously in Pinellas County or have not been a director in Pinellas County in the last 12 months. This course is designed to foster success by covering regulations unique to Pinellas County, our website as a resource and best management practices. A certificate documenting three (3) hours of annual in-service training will be issued.

### DIRECTOR'S ORIENTATION FOR INFANT CARE

A three (3) hour training comprised of regulations pertaining specifically to infant care and best practices in caring for children from birth to 2 years of age. Participants will receive a training packet that includes a copy of the Infant Standards, required and sample forms, and brochures. This training is required for directors who plan to start an infant program. A certificate documenting three (3) hours of annual in-service training will be issued.

*Any persons with a disability requiring reasonable accommodations should call the CCLP office no later than two (2) weeks prior to the training.*

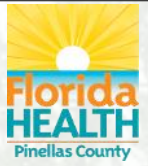

- **“Baby Café®”** is a free and comprehensive breastfeeding support clinics where mothers can meet with an International Board Certified Lactation Consultant (IBCLC) for a one-on-one consultation to address breastfeeding challenges or simply to reassure that all is going well.
- **“What You Do Matters”** is a 6-week educational playgroup supporting caregiver- child interactions in a small group setting to foster community and learn more about developmental milestones. Session topics include fine/gross motor skills, language, social emotional learning and more!
- **ASQ Developmental Screenings** are provided at no cost to monitor your child’s growth in critical areas of development from birth to age 3. We’ll discuss the results with you to support your understanding of your child’s developmental progress, and also provide guidance if additional services are needed.
