This training is appropriate for prospective or new owners/directors and as an update for current child care personnel with record keeping responsibilities. A certificate documenting four and a half (4.5) hours of annual inservice training will be issued. This training is required for directors who plan to start an infant program. A certificate documenting three (3) hours of annual inservice training will be issued.
