Subject: Final Agency Action on Changes to Regulations Effective January 15, 2026

The Pinellas County License Board met on December 3, 2025, and approved the following increases to the regulations for Pinellas County all of which go into effect on January 15, 2026.

Increase 1:

IX. APPLICATION, FEES, LICENSE **B. Fees**

1. The License Board is authorized to charge an application fee not in excess of twenty-five dollars (\$25.00) for each family child care home for which a license is sought. All family child care home application fees are set at **\$25.00**

How to maintain compliance: New, renewal and change applications received after January 15, 2026 will include an application fee of \$25.00.

Increase 2:

IX. APPLICATION, FEES, LICENSE
B. Fees

5. The cost for filing each petition for a variance or waiver from a Pinellas County regulation is \$110.00 and the cost for filing each petition for a variance or waiver from a state regulation is \$125.00 for both Family Child Care Homes and Large Family Child Care Homes.

How to maintain compliance: Anytime a Family Child Care Home, or Large Family Child Care Home applies for a variance or waiver from a Pinellas County Regulation, a payment of \$110.00 must be paid. If a variance or waiver from a state regulation is applied for, a \$125.00 will be paid.

Increase 3:

IX. APPLICATION, FEES, LICENSE
B. Fees

7. Each Family Child Care Home and Large Family Child Care Home will be charged \$35.00 to add overnight care to the license at any time other than at issuance of an initial license or at the time of renewal.

How to maintain compliance: When a Family Child Cre Home or Large Family Child Care provider applies to add over night care at any time other than their annual renewal of application date, they will pay \$35.00.

Increase 4:

IX. APPLICATION, FEES, LICENSE
B. Fees

8. A fee of \$25 for the second reinspection and \$50 for any additional reinspection necessary thereafter will be charged after a family child care home or large family child care home has received a violation of a regulation. There is no fee for the first reinspection.

How to maintain compliance: When a second reinspection is needed, a \$25 fee will be charged to the Family Child Care Home or Large Family Child Care Home. Thereafter, if any additional reinspection is needed, there will be \$50 charge per additional reinspection.



Increase 5:

IX. APPLICATION, FEES, LICENSE
B. Fees

9. As of January 1, 2027, and January 1 of each year thereafter, all fees in these regulations will automatically increase by 3%.

How to maintain compliance: Beginning on January 1, 2027, and each year thereafter, all fees will automatically increase by 3%.
